VAT

Transfer Pricing

Transfer Pricing (TP) is not only a compliance requirement, but proper multi-national planning can save worldwide taxes. Most major trading nations have complex documentation requirements and penalties for non-compliance.

They can then assist with the preparation of TP documentation and dispute resolution (either preempting by way of an Advance Pricing Agreement (APA) or through competent authority).
